Fair Value Information Services

Interactive Data's Fair Value Information Services are designed to provide subscribers with various information that can be used to estimate a price for an exchange-traded equity issue that would likely prevail in a liquid market in view of market information available at the time of evaluation. The services currently offer subscribers the choice of close of New York Stock Exchange, mid-day London stock exchange, or close of London Stock Exchange evaluation times for their securities. We use a multifactor model that includes such input information as the issue's local closing price, relevant general and sector indices, currency fluctuations, depository receipts and futures, as applicable. The model generates an Evaluated Adjustment Factor for each security; essentially, a multiplier that can be applied to the local closing price to adjust it for post-closing events.

Halts and Suspensions Service

Interactive Data provides market activity data from NASDAQ, NYSE, NYSE Amex Equities, and select regional exchanges, as well as other select global non-North American exchanges, to our FundRun clients. You can be informed of halted, suspended, or resumed trading on equity securities within minutes after the activity occurs instead of long after the fact. Open Price File Service

MarketSweepSM

Interactive Data's MarketSweep is designed to meet the fund industry's need for a large number of daily prices for U.S. and Canadian exchange-listed securities in time to report NAVs to the MFQS. To minimize the time between exchange close and data availability on your computer system, Interactive Data utilizes direct exchange feeds as the source of MarketSweep's NYSE, NYSE Amex Equities, NASDAQ, NASDAQ Other OTC, and TSX data.

MarketSweep pricing data for exchange-listed securities, identified by exchange ticker and CUSIP number, includes (as available from the individual exchanges) Open, High, Low, Volume, Close Bid, Close Ask, and Close. You can receive all available exchange-provided equity and bond prices from one or more exchanges, or a select universe.

OTC Derivatives Valuation Service
